This statement is filed pursuant to Rule 13d-2(b) with respect to the shares of common stock (the "Common Stock") of New Century Companies, Inc. The names of the persons filing this statement on Schedule 13G are: Castlerigg Master Investments Ltd., a British Virgin Islands company ("Castlerigg Master Investments"), Sandell Asset Management Corp., a British Virgin Islands company ("SAMC"), Castlerigg International Limited, a British Virgin Islands company ("Castlerigg International"), Castlerigg International Holdings Limited, a British Virgin Islands company ("Castlerigg Holdings"), and Thomas E. Sandell, a citizen of Sweden ("Sandell").

### ITEM 4. OWNERSHIP.

Provide the following information regarding the aggregate number and percentage of the class of securities of the issuer identified in Item 1.

#### (a) Amount beneficially owned:

The Reporting Persons beneficially own 785,000 shares of Common Stock consisting of (i) the Issuer's Series D Convertible Preferred Stock convertible into 400,000 shares of Common Stock, and (ii) warrants exercisable for 385,000 shares of Common Stock.

#### (b) Percent of Class:

The Reporting Persons beneficially own 785,000 shares of Common Stock representing 9.8% of all the outstanding shares of Common Stock.
