ITEM 5. OTHER EVENTS

We are filing this report on Form 8-K to disclose the following recent developments, and to incorporate such disclosure into our Registration Statement on Form S-3 (Registration No. 333-66694) and our Registration Statement on Form S-3 (Registration Statement No. 333-83984):

(a) Increases to Credit Agreements. On March 15, 2002, we amended our aggregation facility with CDC Mortgage Capital to increase the maximum amount from \$200 million to \$400 million. On March 25, 2002 we amended our U.S. Bank warehouse credit agreement to increase the amount from \$300 million to \$410 million.
