- (1) Includes 4,452 shares of stock acquired through the reinvestment of dividends on September 30, 2005, at a price of \$62.0622 per share.

The actual number of shares issuable upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund.
