RSUs are granted annually at the Compensation and Leadership Development committee's first meeting in January or February and vest in 1/3 increments on the date of the committee's first annual meeting in the first, second and third years after the award was granted. Award balances accrue additional RSUs through quarterly dividend reinvestment that vest on the same schedule as the underlying award.

(3) Balance includes 141 shares acquired through quarterly dividend reinvestment during 2018.

(4) Balance includes 211 shares acquired through quarterly dividend reinvestment during 2018.
