## **Refining Record**

(Rio de Janeiro, October 08, 2003). PETRÓLEO BRASILEIRO S/A - PETROBRAS, [Bovespa: PETR3/PETR4, NYSE: PBR/PBRA, Latibex: XPBR/XPBRA], a Brazilian international energy company, announces on October 6, Petrobras' Downstream/Refining department set a new one-day record. It processed 1,795,278 barrels in the distillation units at its Brazilian refineries. This volume beat the previous record of 1,785,000 bpd processed on June 24, 1999.

The new record reflects ongoing improvement in the processes the units are using in their quest for operating excellence, enabling them to process throughput volumes reliably, without endangering people, equipment or the environment, but also without reducing profitability while at the same time demonstrating the reliability and strength with which the downstream logistics chain has been integrated.
