All 14,891,833 shares reported on this Schedule are held directly by Vicis Capital Master Fund, for which Vicis Capital LLC acts as investment advisor. Vicis Capital LLC may be deemed to beneficially own such 14,891,833 shares within the meaning of Rule 13d-3 of the Securities Exchange Act of 1934, as amended, by virtue of the voting and dispositive power over such shares granted by Vicis Capital Master Fund to Vicis Capital LLC. The voting and dispositive power granted to Vicis Capital LLC by Vicis Capital Master Fund may be revoked at any time. Vicis Capital LLC disclaims beneficial ownership of any shares reported on this Schedule.

(b) Percent of Class:

22.9%. Based upon 64,957,462 shares of the Issuer's Common Stock outstanding at August 12, 2009, as reported by Glowpoint, Inc. in its Quarterly Report on Form 10-Q filed on August 12, 2009, and taking into account the limitations contained in the Issuer's Series A-2 Convertible Preferred Stock that is owned by Vicis, which limitations prevent Vicis from converting such Series A-2 Convertible Preferred Stock if such conversion would result in Vicis beneficially owning greater than 4.99% of the Common Stock outstanding at such time.
