Represents shares of Common Stock, par value \$0.10 per share, of The Children's Place Retail Stores, Inc. (the "Company"), underlying time restricted stock units granted under the Company's 2011 Equity Incentive Plan (the "Plan") on February 15, 2013. Such shares vest (1) in five equal annual installments beginning on April 1, 2014, and vested shares are deliverable upon the earlier to occur of (i) April 1, 2018 or within 10 days following Mr. Low's death or disability, provided Mr. Low is employed by the Company on each of such dates, or (ii) following Mr. Low's termination without cause, all as further subject to the terms and conditions of the Plan.
