This Amendment No. 2 ( <u>"Amendment"</u> ) amends and supplements the Schedule 13D originally filed on June 17, 2014, as amended on October 28, 2014 ( <u>"Original Schedule 13D"</u> ), by Mr. Raymond C. Stachowiak ( <u>"Reporting Person"</u> ), relating to the class of common stock, no par value ( <u>"Common Stock"</u> ) of American Shared Hospital Services, a California corporation ( <u>"Issuer"</u> ).
