- (1) On March 30, 2007, the common stock of Cabot Oil & Gas Corporation split 2-for-1, resulting in the reporting person's acquisition of 4,221 additional shares of common stock.
- (2) This option was previously reported as covering 15,000 shares at an exercise price of \$47.575, but was adjusted to reflect the 2-for-1 stock split on March 30, 2007.
- (3) On March 30, 2007, the common stock of Cabot Oil & Gas Corporation split 2-for-1, resulting in the reporting person's acquisition of 15,000 additional shares of common stock.
