### ITEM 7.01. Regulation FD Disclosure

On May 1, 2007, FTI Consulting, Inc. (FTI) held a conference call relating to our financial results for the first quarter ended March 31, 2007, operating results by business segment, guidance for 2007 and other information. The full text of the Transcript of the conference call is furnished as Exhibit 99.1 hereto and incorporated by reference herein.

The Transcript contains some discussion regarding FTI s earnings before interest, taxes, depreciation and amortization, amortization of intangible assets and litigation settlements (EBITDA), EBITDA by business segment and EBITDA margins. Although the forgoing financial measures are not measures of financial condition or performance determined in accordance with generally accepted accounting principles (GAAP), FTI believes that they are useful operating performance measures for evaluating our results of operations from period to period and year to year, and as compared to our competitors. EBITDA is a common alternative measure of operating performance used by investors, financial analysts and rating agencies to value and compare the financial performance of companies in our industry. FTI uses EBITDA to evaluate and compare the operating performance of its segments and it is one of the primary measures used to determine employee bonuses. FTI also uses EBITDA to value businesses it considers acquiring. The non-GAAP financial measures discussed by FTI are not defined in the same manner by all companies and may not be comparable to other similarly titled measures of other companies unless the definition is the same. We believe that EBITDA as a supplemental financial measure is also indicative of FTI s capacity to incur and service debt and thereby provides additional useful information to investors regarding FTI s financial condition and results of operations. EBITDA for purposes of the covenants set forth in our senior secured credit facility are not calculated in the same manner as calculated for other purposes.
