Manko, Jr. (collectively with HCPF, HCP and HCM, the Reporting Persons ), with respect to shares of common stock of the above-named issuer owned by HCPF, a Delaware limited partnership.

HCPF owns directly 2,177,804 shares of Common Stock. Pursuant to investment management agreements, HCM maintains investment and voting power with respect to the securities held by HCPF. However, despite the delegation of investment and voting power to HCM, HCP may be deemed to be the beneficial owner of such securities under Rule 13d-3 of the Act because HCP has the right to acquire investment and voting power through termination of investment management agreements with HCM. HCM also acts as an investment adviser to certain managed accounts. Under investment management agreements with managed account clients, HCM has investment and voting power with respect to 20,000 shares of Common Stock held in the client managed accounts. HCP is the general partner of HCPF. Mr. Manko is the managing member of both HCM and HCP. By reason of the provisions of Rule 13d-3 of the Act, each of HCM and Mr. Manko may be deemed to beneficially own 2,197,804 shares of Common Stock, and HCP may be deemed to beneficially own 2,177,804 shares of Common Stock held by HCPF. Each of the Reporting Persons disclaims beneficial

ownership of any of the securities covered by this statement.
