- (1) Cumulative Convertible Trust Preferred Securities of 2.8249 shares of common stock for each Trust Preferred Security tendered and (ii) 104,808 shares of common stock pursuant to a premium in the issuer conversion offer of 1.7468 shares of common stock for each Trust Preferred Security tendered.
- (2) I disclaim beneficial ownership of these shares owned by my wife.
- (3) I disclaim beneficial ownership of these shares held by my wife as custodian for two of my children.
- (4) I am the trustee of these trusts for two of my children. I disclaim beneficial ownership of these shares.
