  - (1) These restricted stock units are subject to performance-based vesting conditions based on the company's actual results compared to financial objectives established under the long-term incentive compensation plan, and vest 100% on February 22, 2015, subject to achievement of the performance-based vesting conditions.
  - (2) These restricted stock units are issued under Sprint Nextel's 2007 Omnibus Incentive Plan. Each unit represents the right to receive one share of the underlying security at a date in the future.
  - (3) Includes 401,859 restricted stock units, which are subject to forfeiture until they vest.
  - (4) These options become exercisable at the rate of 33 1/3% of the number of shares granted on each of the first three anniversaries of the grant date.
