(1) Shares of the Company's Class A Common Stock received from the vesting of 1/12 of the restricted stock unit award granted on December 3, 2012.

The stock units will be fully vested on December 3, 2015.

(6) Excludes previously granted restricted stock units for an aggregate of 13,235 shares of Class A Common Stock, which have different vesting schedules.

(7) The performance-based restricted stock units were granted on November 28, 2011 under the Cognizant Technology Solutions Corporation 2009 Incentive Compensation Plan. In accordance with the performance-based restricted stock unit award, 1/2 of the vested performance-based restricted stock units were issuable on June 3, 2013, provided the reporting person remained in the Company's service through such date. The remaining 1/2 of the vested performance-based restricted stock units shall be issued on December 1, 2014, provided that the reporting person remains in the Company's service through such date.

(8) Excludes previously granted restricted stock units for an aggregate of 19,205 shares of Class A Common Stock, which have different vesting schedules.
