- (1) On July 21, 2017, 13,500 shares of Common Stock issued to the reporting person as Performance Earned Restricted Stock pursuant to the RPM International Inc. 2004 Omnibus Equity and Incentive Plan (the "Plan") vested. In accordance with the Plan, the reporting person disposed of 4,165 shares of Common Stock back to the Issuer to satisfy tax obligations of the reporting person.
- (2) Includes an aggregate of 32,808 shares of Common Stock issued pursuant to the 2007 RPM International Inc. Restricted Stock Plan, 23,500 shares of Common Stock, issued as Performance Earned Restricted Stock, pursuant to the RPM International Inc. 2014 Omnibus Equity and Incentive Plan, and 16,000 shares of Common Stock, issued as Performance Contingent Restricted Stock, pursuant to the RPM International Inc. 2014 Omnibus Equity and Incentive Plan.
