Estimated Unaudited Returns

The following information is being provided to investors in the alternative investment vehicles (the “funds”) that affiliates of Och-Ziff Capital Management Group LLC (collectively, the “Company”) manage with respect to the estimated performance of the Company’s most significant master funds for the month ended January 31, 2015. The following information is not necessarily indicative of the Company’s anticipated financial results.

Monthly performance data are based on management’s estimates as of the date hereof for performance of the (1)referenced funds from January 1, 2015 to January 31, 2015. Such data may change upon completion of the Company’s month-end valuation procedures, and any changes could be material.

Net return represents a composite of the average return of the feeder funds that comprise each of the referenced funds. Net return is presented on a total return basis, net of all fees and expenses (except incentive income on unrealized gains attributable to investments that the Company, as investment manager, determines lack a readily ascertainable fair value, are illiquid or otherwise should be held until the resolution of a special event or circumstance (“Special Investments”) that could reduce returns on such Special Investments at the time of (2)realization) and includes the reinvestment of all dividends and other income. Performance includes realized and unrealized gains and losses attributable to Special Investments and initial public offering investments that are not allocated to all investors in the feeder funds. Investors that were not allocated Special Investments and/or initial public offering investments may experience materially different returns. The performance calculation for the OZ Master Fund excludes realized and unrealized gains and losses attributable to currency hedging specific to certain investors investing in OZ Master Fund in currencies other than the U.S. Dollar.

Estimated Unaudited Assets Under Management

In addition, the Company is disclosing to investors in the funds that it manages that, as of February 1, 2015, the estimated unaudited amount of assets under management was approximately \$46.7 billion, which reflects a net increase of approximately \$700 million since January 1, 2015. The Company’s estimate of assets under management is inclusive of performance for the month ended January 31, 2015 and capital flows from January 2, 2015 through February 1, 2015, and includes a \$152 million reduction in assets under management resulting from the expiration of the investment period of one of our credit funds. In addition, beginning in February 2015, the measurement of assets under management by the Company includes gross assets on which management fees are based for certain performing credit products, which resulted in an increase in assets under management of \$167 million.

Assets under management includes assets attributable to the Company’s multi-strategy, credit, real estate and equity funds, collateralized loan obligations (CLOs), other performing credit assets on which the Company earns fees, and other alternative investment vehicles it manages. Management fees and incentive income earned on assets under management may vary depending on the asset class, performance measurement period, amount of capital committed by investors, and other factors related to a particular fund.
