Prior awards of restricted share units, which have different vesting provisions, have been reported in Table II. Total also reflects change in form of beneficial ownership from direct to indirect (by trust) for 106,500 shares.

reason of the antitrust laws, compliance with conflict of interest policies, death, disability or other circumstances that the Board deems not to be adverse to the best interests of ArvinMeritor.
