(1) The deferred compensation stock units were acquired under the Brady Corporation director deferred compensation plan. The deferred compensation units become payable in shares of Brady's Class A Common Stock upon the reporting persons cessation of service as a director. Includes 1,450 shares issued on September 30, 2011 pursuant to a new equity compensation plan for non-management directors.
