As of June 30, 2015, Bulldog Investors, LLC is deemed to be the beneficial owner of 349,900 shares of GDEF by virtue of Bulldog Investors, LLC's power to direct the vote of, and dispose of, these shares. These 349,900 shares of GDEF include 193,481 shares (representing 2.01% of GDEF's outstanding shares) that are beneficially owned by the following entities over which Messrs. Goldstein, Dakos and Samuels exercise control: Opportunity Partners LP, Calapasas West Partners LP, Full Value Special Situations Fund LP, Full Value Offshore Fund Ltd., Full Value Partners LP, Opportunity Income Plus Fund LP, MCM Opportunity Partners LP (collectively, Bulldog Investors Funds). Bulldog Investors Funds may be deemed to constitute a group. All other shares included in the aforementioned 349,900 shares of GDEF owned by Bulldog Investors, LLC (solely by virtue of its power to sell or direct the vote of these shares) are also beneficially owned by clients of Bulldog Investors, LLC who are not members of any group. The total number of these "non-group" shares is 156,419 shares (representing 1.63% of GDEF's outstanding shares).
