- (1) Deferred stock units (DSUs) to be settled in shares of Motorola Solutions Inc. common stock upon termination of service from the Motorola Solutions, Inc. Board of Directors. These DSUs were acquired in lieu of the right to receive cash in connection with the acquisition of Motorola Mobility Holdings, Inc. by Google Inc., for the 8,580 DSUs relating to shares of common stock of Motorola Mobility Holdings, Inc. The Motorola Mobility Holdings, Inc. DSUs were originally received as dividend equivalent rights in connection with the separation of Motorola Mobility Holdings, Inc. from Motorola Inc.
- (2) Includes shares acquired through the reinvestment of dividends and deferred stock units received pursuant to dividend equivalent rights which were credited to the reporting person when and as dividends were paid on Motorola Solutions, Inc. common stock.
- (3) Samuel C. Scott III is the trustee of a Money Purchase Pension Plan Trust for Samuel C. Scott III.
