NFJ is an indirectly wholly-owned subsidiary of AGI U.S. Holdings and an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, as amended.

The securities reported in this Schedule 13G are held by investment advisory clients or discretionary accounts of which NFJ is the investment adviser. When an investment management contract (including a sub-advisory agreement) delegates to NFJ investment discretion or voting power over the securities held in the investment advisory accounts that are subject to that agreement, AGI U.S. Holdings treats NFJ as having sole investment discretion or voting authority, as the case may be, unless the agreement specifies otherwise. Accordingly, NFJ reports on Schedule 13G that it has sole investment discretion and voting authority over the securities covered by any such investment management agreement. As a result, NFJ may be deemed to beneficially own the securities held by its clients or accounts within the meaning of rule 13d-3 under the Act. AGI U.S. Holdings and NFJ share investment management personnel. Therefore, AGI U.S. Holdings may be deemed to beneficially own the securities held by the clients or accounts of NFJ
