- (1) Shares were sold pursuant to a 10b5-1 Trading Plan in order to raise funds to pay the required withholding tax pursuant to the vesting of RSUs.  

The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$380.06 to \$380.83, inclusive.
