- (1) On August 30, 2016, the reporting person exercised 15,000 stock options, delivered 10,248 shares of Common Stock of the Company for cancellation in payment of the exercise price of such options, and had 1,758 shares of Common Stock of the Company withheld and cancelled to cover minimum required tax withholdings. These share cancellations are shown in Table I as dispositions (Transaction Code "D" in column 4), although none of these cancelled shares were sold in the market, as indicated by Transaction Code "F" in column 3.
- (2) The NFG stock fund under the NFG 401(k) plan is denominated in units, representing ownership interests in a fund that includes both NFG common stock and a reserve of cash. The information reported represents the dollar value of the reporting person's balance in the NFG stock fund as of August 30, 2016, as reported by the plan administrator, divided by the closing price of NFG common stock on that

- (3) The NFG employee stock ownership plan is denominated in units, representing ownership interests in a fund that includes both NFG common stock and a reserve of cash.
