On September 22, 2014, the Compensation & Human Resources Committee of First Commonwealth Financial Corporation (the “Company”) approved the payment of \$47,913.95 to T. Michael Price, President and Chief Executive Officer of the Company, as reimbursement for costs incurred by Mr. Price in connection with his relocation from Johnstown, Pennsylvania, to Indiana, Pennsylvania.
