(1) On July 11, 2006 PACCAR declared a stock dividend of one additional share of common stock for every two shares of common stock payable August 10, 2006 to all holders of record of common stock on July 27, 2006. As a result of the stock dividend the reporting person received 2,682 additional shares of PACCAR common stock on August 10, 2006.

(2) Shares held in PACCAR Savings Investment Plan (SIP). Shares not adjusted for 50% stock dividend pending receipt of SIP trustee's report.

(3) Option to buy awarded under PACCAR Long Term Incentive Plan (LTIP).
