The reporting person became 50% vested in her 6/15/09 award upon the first anniversary of the date of the grant of the award and will become vested in the remaining 50% of her award of 50,000 restricted stock units on the second anniversary of the award, but the award may vest earlier in the event of death, disability or retirement. Vested shares are to be delivered to the reporting person within 30 days following the date of vesting. Prior to the vesting of the award, if the Company pays a dividend on its common stock, the reporting person will receive an amount in cash equal in value to the dividends that the reporting person would have received had the reporting person been the actual owner of the Newell Rubbermaid common stock represented by the restricted stock units.
