("ENF"), at the closing of the transactions contemplated by the Arrangement Agreement on November 8, 2018, each common share of ENF ("ENF Share") was exchanged for 0.7350 of a common share of Enbridge and cash of CAN\$0.45 per ENF Share. The market value of shares of Enbridge's common stock at the closing of such transactions was CAN\$43.32.
- (2) Includes 6,366 Enbridge Common Shares acquired by the Reporting Person between March 24, 2018 and November 8, 2018 under the Enbridge Employee Savings Plan in transactions that were exempt under Rule 16b-3(c), and 18,064 Enbridge Common Shares acquired by the Reporting Person between March 24, 2018 and November 8, 2018 under the Enbridge Dividend Reinvestment and Share Purchase Plan in transactions that were exempt under Rule 16a-11.
