Item 5.02 Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers.

On December 21, 2015, the Company filed a Current Report on Form 8-K (the “Initial 8-K”) disclosing that the Board of Directors (the “Board”) of AK Steel Holding Corporation (the “Company”) had expanded its number of authorized directors from twelve to thirteen and elected Mr. Gregory B. Kenny as a director of the Company, effective January 1, 2016, to fill the vacancies created by the expansion. Committee assignments for Mr. Kenny had not been determined as of the filing of the Initial Form 8-K.

On May 26, 2016, effective immediately, the Board appointed Mr. Kenny to its Finance Committee, Management Development and Compensation Committee, and Nominating and Governance Committee, having previously determined that he satisfies all applicable requirements to serve on such Committees, including without limitation the applicable requirements of the New York Stock Exchange Listed Company Manual and the Securities Exchange Act of 1934, as amended.
