DTE Energy Company ("DTE Energy") will meet with investors on November 17, 2014. A copy of the slide presentation from the meetings was previously furnished as Exhibit 99.1 to the Form 8-K filed November 10, 2014 and is available on DTE Energy's website, www.dteenergy.com. In those meetings and in the slide presentation, DTE Energy reaffirms its 2014 operating earnings per share guidance of \$4.28-\$4.42 per share and provides an early outlook for its 2015 operating earnings per share guidance of \$4.43-\$4.67 per share.

In its slide presentation and this filing, DTE Energy discusses 2014 and 2015 operating earnings guidance. It is likely that certain items that impact the company's 2014 and 2015 reported results will be excluded from operating results. Reconciliations to the comparable 2014 and 2015 reported earnings guidance are not provided because it is not possible to provide a reliable forecast of specific line items. These items may fluctuate significantly from period to period and may have a significant impact on reported earnings.
