DTE Energy Company ("DTE Energy") will meet with investors March 20-22, 2017. In the meetings, DTE Energy reaffirms its 2017 operating earnings per share guidance of \$5.15-\$5.46 per share.

In its slide presentation and this filing, DTE Energy discusses 2017 operating earnings guidance. It is likely that certain items that impact the company's 2017 reported results will be excluded from operating results. Reconciliations to the comparable 2017 reported earnings guidance are not provided because it is not possible to provide a reliable forecast of specific line items (i.e. future non-recurring items, certain mark-to-market adjustments and discontinued operations). These items may fluctuate significantly from period to period and may have a significant impact on reported earnings.
