- Represents the purchase of 140,000 shares by Barnes & Noble College Booksellers, Inc., a New York corporation beneficially owned by
- (1) the Reporting Person ("B&N College"), pursuant to Securities Exchange Act Rule 10b-18 ("Rule 10b-18") in seven separate transactions at per share prices ranging from \$26.9597 to \$28.6461, resulting in a weighted average purchase price per share of \$28.0422.
  - (2) Of these shares, 712,473 shares are owned indirectly in a rabbi trust established by the Issuer for the benefit of the Reporting Person.
  - (3) Of these shares, 5,007,934 shares are owned indirectly through B&N College.
  - (4) Represents the purchase of 140,000 shares by B&N College, pursuant to Rule 10b-18 in four separate transactions at per share prices ranging from \$27.8805 to \$28.0925, resulting in a weighted average purchase price per share of \$28.0007.
  - (5) Of these shares, 5,147,934 shares are owned indirectly through B&N College.
