The award is scheduled to vest as to 7,038 stock units on January 9, 2008 and as to the remaining 7,038 stock units on January 9, 2010.

(3) Options were granted under the Company's 1995 Stock Option Plan in a transaction exempt under Rule 16(b)-3. The options vest in four equal installments on each January 9 of 2007 through 2010.
