Item 6. Ownership of More than Five Percent on Behalf of Another Person:

Westport Asset Management, Inc. is deemed to be a beneficial owner for purposes of Rule 13-d since it has shared power to make decisions whether to retain, dispose of the securities of many unrelated clients. Westport Asset Management, Inc. does not, however, have an economic interest in the securities of those clients. The clients are actual owners of the securities and have the sole right to receive and the power to direct the receipt of dividends from or proceeds from the sale of such securities. The Reporting Person disclaims beneficial ownership of such shares and disclaims the existence of any group.

Westport Asset Management, Inc. owns 50% of Westport Advisors LLC, which is also an investment adviser registered under Section 203 of the Investment Advisors Act of 1940. With regard to the shares set forth under Item 4. (c) (ii) and (iv), Westport Asset Management Inc. and Westport Advisors LLC are deemed to be beneficial owners for purposes of Rule 13-d since they both have shared power to make decisions whether to retain or dispose and vote the securities. Westport Advisors LLC serves as investment manager of The Westport Funds, mutual funds which hold such shares in the ordinary course of their business not with the purpose nor with the effect of changing or influencing the control of the issuer.
