Item 2.01 COMPLETION OF ACQUISITION OR DISPOSITION OF ASSETS

On December 2, 2010 RadNet, Inc. (“RadNet”) consummated the acquisition of five medical imaging facilities located in New Jersey pursuant to the definitive purchase agreement dated as of September 7, 2010 for an aggregate of \$17.150 million in cash.
