## EXPLANATORY NOTE

This Amendment No. 5 to Schedule 13D (the Amendment ) is being filed with respect to the Reporting Persons beneficial ownership in DeVry Education Group Inc. ( DeVry or the Issuer ). This amendment supplements the Schedule D as previously filed on June 22, 2016 (as amended, the Schedule 13D ). Each Item below amends and supplements the information disclosed under the corresponding Item of the Schedule 13D. Unless otherwise indicated herein, capitalized terms used but not defined in this Amendment shall have the same meaning herein as are ascribed to such terms in Schedule 13D.

### Item 5. Interest in Securities of the Issuer

Item 5 a. and b. is hereby amended and restated as follows:

The aggregate percentage of Share reportedly owned by each person named herein is based upon 62,623,000 Shares outstanding, as of October 27, 2016 and reported in the Issuer s Form 10-K filed on November 2, 2016.

1. IVA

- a) As of November 21, 2016, 7,870,682 Shares in aggregate were deemed to be beneficially owned by IVA, as the investment manager to i) WORLD which owns 4,828,004 Shares constituting 7.7% of the Issuer s outstanding Shares, ii) IVAGMF which owns 350,452 Shares constituting 0.6 % of the Issuer s outstanding Shares, iii) SICAV which owns 573,759 Shares constituting 0.9% of the Issuer s outstanding Shares, and iv) the Managed Accounts which own 2,118,467 Shares constituting 3.4% of the Issuer s outstanding Shares.
