(a) Name of Person Filing Aon Corporation (Aon) is filing this amendment to Schedule 13G on behalf of itself and certain of its current and former subsidiaries and affiliates, including Virginia Surety Company, Inc. (formerly known as Combined Specialty Insurance Company) (VSC), Combined Insurance Company of America (CICA), Resource Life Insurance Company (Resource Life), London General Insurance Company Limited (London General), Sterling Life Insurance Company (Sterling Life), Combined Life Assurance Company of Europe Limited (CLACE), Aon Warranty Services, Inc. (AWS) and the Aon Pension Plan (the Pension Plan). Aon, CICA, Sterling Life, CLACE and the Pension Plan are referred to collectively in this amendment as the Aon Entities. On November 30, 2006, Aon completed the sale of VSC, Resource Life, London General and AWS (the Warranty Entities).
