(the Company) and Brinson Patrick Securities Corporation (Brinson Patrick), which has been filed as an exhibit to a report on Form 8-K with the Securities and Exchange Commission (SEC) on October 3, 2005, and which is incorporated by reference herein, during the three months ended March 31, 2007 the Company sold, through Brinson Patrick, as agent of the Company, an aggregate of 24,700 shares of the Company's 9.125% Series C Cumulative Redeemable Preferred Stock, liquidation preference \$25.00 per share (the Series C Preferred Stock), pursuant to ordinary brokers' transactions on the New York Stock Exchange.
