Represents the acquisition of shares pursuant to a quarterly grant of restricted common stock pursuant to the Director compensation program. The shares of restricted stock vest in three equal annual installments commencing on the first anniversary of the grant date. As

(1) provided by the terms of such program, (i) the grant date is the fifth trading day following the filing of the Issuer's Quarterly Report on Form 10-Q; and (ii) the number of shares was determined based on a grant value of \$68,750 and a price of \$14.895 per share, the average of the closing prices on the ten trading days prior to the date of grant.

(2) shares was incorrectly reported as 4.615 as opposed to 4,615. Similarly, the Form 4 filed by the reporting person on September 14, 2010 contained a clerical error whereby the number of shares was incorrectly reported as 4.616 as opposed to 4,616.
