(1) In connection with the merger of CapitalSource Inc. with and into PacWest Bancorp on April 7, 2014 pursuant to the Agreement and Plan of Merger, dated July 22, 2013, as amended, between PacWest and CapitalSource, the reporting person received (i) 9,986 shares of the PacWest common stock reported above, together with \$86,955 in cash, in exchange for 35,200 shares of CapitalSource common stock and (ii) PacWest phantom stock with respect to 37,910 shares of the PacWest common stock reported above in exchange for 111,567 shares of CapitalSource phantom stock. The shares of PacWest common stock underlying the PacWest phantom stock are payable upon the earlier of termination of the reporting person's service as a director of PacWest and April 7, 2015. On April 7, 2014, the effective date of the merger, the closing price of CapitalSource's common stock was \$15.50 per share and the closing price of PacWest's common stock was \$45.83 per share.
