#### Item 8.01. Other Events.

On January 7, 2015, Air Lease Corporation (the Company) entered into an underwriting agreement (the Underwriting Agreement) with BNP Paribas Securities Corp., Citigroup Global Markets Inc., Deutsche Bank Securities Inc. and J.P. Morgan Securities LLC, for themselves and on behalf of the several underwriters listed in Schedule 1 thereto (collectively, the Underwriters), relating to the public offering of \$600 million in aggregate principal amount of 3.750% unsecured senior notes due 2022 (the Notes).

The Notes are being offered pursuant to an effective shelf registration statement (File No. 333-184382) that the Company previously filed with the Securities and Exchange Commission (the SEC), as supplemented by a preliminary prospectus supplement filed with the SEC on January 7, 2015, and a final prospectus supplement filed with the SEC on January 8, 2015. The offering of the Notes is expected to close on January 14, 2015, subject to satisfaction of customary closing conditions.

The foregoing description is not complete and is qualified in its entirety by reference to the complete text of the Underwriting Agreement filed as Exhibit 1.1 hereto and incorporated herein by reference.

Some of the Underwriters and their affiliates have engaged in, and may in the future engage in, investment banking and other commercial dealings in the ordinary course of business with the Company or its affiliates. They have received, or may in the future receive, customary fees and commissions for these transactions. Deutsche Bank Trust Company Americas, an affiliate of Deutsche Bank Securities Inc., one of the Underwriters, is the trustee under the indenture that will govern the Notes. Affiliates of the Underwriters may receive a portion of the net proceeds from the offering of the Notes, to the extent the Company uses such net proceeds to repay indebtedness under which certain of the Underwriters or their affiliates are lenders.

The Company issued a press releases announcing the pricing of the Notes on January 7, 2015. A copy of the press release is filed as Exhibit 99.1 to this report and incorporated herein by reference.
