This joint statement on Schedule 13G is being filed by Steven Tannenbaum, Greenwood Investments, Inc., Greenwood Capital Limited Partnership, Shawkemo Hills LP, and ST Partners LLC, who are collectively referred to as the Reporting Persons. Mr. Tannenbaum is the President of Greenwood Investments, Inc. (the General Partner ), which is the sole general partner of Greenwood Capital Limited Partnership ( Capital ) and Shawkemo Hills LP ( Shawkemo ). Mr. Tannenbaum is the manager and sole member of ST Partners LLC ( ST Partners ). The Reporting Persons have entered into a Joint Filing Agreement, dated as of the date hereof, a copy of which is filed with this Schedule 13G as Exhibit 1 (which is incorporated herein by reference), pursuant to which the Reporting Persons have agreed to file this statement jointly in accordance with the provisions of Rule 13d-1(k) under the Act.

**Item 4.**

**Ownership:**

As of February 20, 2018 the Reporting Persons, in the aggregate, beneficially own 676,639 shares of Common Stock of the Issuer, representing approximately 4.48% of such class of securities. The beneficial ownership of each Reporting Person is as follows: (i) Capital beneficially owns 402,308 shares of Common Stock representing approximately 2.84% of the class; (ii) Shawkemo beneficially owns 233,701 shares of Common Stock representing approximately 1.65% of the class (ii) ST Partners beneficially owns 40,630 shares of Common Stock representing approximately 0.28% if the class, (iii) the General Partner, as the sole general partner of Capital and Shawkemo, beneficially owns 636,009 shares of Common Stock representing approximately 4.49%% of the class, and (iv) Mr. Tannenbaum, as the president of the General Partner and the manager and sole member of ST Partners, beneficially owns 676,639 shares of Common Stock of the Issuer representing approximately 4.78% of the class. The percentage of Common Stock beneficially owned by each Reporting Person is based on a total of 14,136,004 shares of Common Stock of the Issuer outstanding as of February 8, 2018 as reported in the most recent quarterly report of the Issuer on Form 10-Q for the fiscal quarter ended December 31, 2017.

Each of Capital, Shawkemo and ST Partners has the power to vote and dispose of the shares of Common Stock beneficially owned by such entity (as described above). The General Partner, as the sole general partner of Capital and Shawkemo, has the authority to vote and dispose of all of the shares of Common Stock owned by such entities. Mr. Tannenbaum, by virtue of his position as president of the General Partner and as manager and sole member of ST Partners, has the authority to vote and dispose of all of the shares of Common Stock reported in this Schedule 13G.
