**SUBJECT:** Market speculation and distractions

Many of you will have seen the media coverage over the last few days regarding a possible unsolicited, no premium bid from Barrick to acquire Newmont. In addition, on Friday afternoon we received a notice of intent from Barrick proposing amendments to Newmont's by-laws at our next annual general meeting that would lower the share ownership threshold required to call shareholder meetings. We have evaluated the possibility of combining with Barrick and others for a number of years. The value proposition of those options is significantly inferior to our merger with Goldcorp and do not offer the same potential for long-term value creation. In fact, there would be significant risks in a combination with Barrick, including Barrick's lack of an effective operating model; a large proportion of their assets being located in unfavorable jurisdictions; and a track record of diminishing shareholder returns.

Our announced combination with Goldcorp represents an unparalleled opportunity to create the world's leading gold company with an unmatched portfolio of operations, projects, exploration opportunities, reserves and people. It is for this reason we remain focused on closing the transaction with Goldcorp.

The Newmont and Goldcorp integration teams are in full swing developing functional plans to help ensure a safe and successful integration.

We also continue making progress on securing regulatory approvals necessary for closing of the transaction. Canada's Competition Bureau issued a no action letter clearing the merger under Canadian competition law. Assuming all necessary approvals and other conditions for closing are met in a timely fashion, we anticipate closing the transaction as early as mid-April. We will continue providing updates as we move towards closing and beyond. In the meantime, if you have questions, please speak directly with your manager or contact the Legal department.

We recognize that this ongoing speculation and activity can be a distraction, and we ask that everyone remain focused on working safely, above all else.
