- (1) This Amendment to the Form 4 originally timely filed April 5, 2004 reflects an additional 85 shares of The St. Paul Travelers Companies, Inc. ("St. Paul Travelers") common stock which were then held by the Reporting Person and reported on his Form 3 filed on April 1, 2004 but which were inadvertently omitted from the direct holdings originally reported in column 5 of Table I of the Form 4.
- (2) Shares of St. Paul Travelers common stock received in exchange for shares of Class A and Class B Common Stock of Travelers Property Casualty Corp. ("Travelers") in connection with the merger between Travelers and The St. Paul Companies, Inc. ("St. Paul"). Pursuant to the merger, each share of Travelers Class A and Class B Common Stock was exchanged for .4334 of a share of St. Paul Travelers Common Stock, with cash paid for any fractional Travelers share. On April 1, 2004, the effective date of the merger, the closing price of St. Paul Common Stock was \$40.77, and the closing prices of Travelers Class A and Class B Common Stock were \$17.57 and \$17.40 per share, respectively.
