  - (1) Shares of restricted stock granted on February 3, 2012 under the Issuer's 2009 Long Term Incentive Plan, as amended. By way of reference, the closing price per share of the Issuer's common stock on the New York Stock Exchange on February 3, 2012 was \$16.45.
