Following the transactions reported on this Form 4, Ms. Koster continues to hold 30,186 shares directly and 1,022 shares indirectly in a (2) 401(k) account. Ms. Koster also holds an additional 103,036 vested stock options, 29,449 unvested stock options, and 8,397 target performance shares (the exact number awarded being dependent on achievement of performance goals).

Amount reported has been adjusted to include 63 shares of Issuer common stock acquired by the reporting person under The Prudential (3) Employee Savings Plan between December 31, 2013 and September 30, 2014 based on a plan statement dated September 30, 2014. The acquisition of such shares was exempt from Section 16 pursuant to Rules 16b-3(c) and 16a-3(f)(1)(i)(B).
