- (1) On February 10, 2015, the reporting person was granted restricted stock units ("RSUs") representing rights to receive shares of common stock of SLM Corporation (the "Company"), subject to vesting conditions, to vest in one-third increments on February 10, 2016, 2017 and 2018. On February 10, 2018, 16,931 shares vested in connection with these RSUs, of which 7,773 shares were withheld by the Company to satisfy the reporting person's tax withholding obligations.
- (2) On February 10, 2015, the reporting person was granted restricted stock units ("RSUs") representing rights to receive shares of common stock of SLM Corporation (the "Company"), subject to transfer restrictions that lapse in one-third increments on February 10, 2016, 2017 and 2018. On February 10, 2018, the transfer restrictions lapsed in connection with 9,608 of these RSUs, of which 4,182 shares were withheld by the Company to satisfy the reporting person's tax withholding obligations.
