- (1) Since the date of the reporting person's last ownership report, he transferred 2,471 shares of the Issuer's Class A common stock pursuant to a domestic relations order. The reporting person no longer reports as beneficially owned any securities owned by his former spouse.

 - (6) The RSUs shall vest quarterly as to 1/16th of the total shares, commencing the first quarter following November 15, 2018, subject to continued service through each vesting date.
