Item 1. Security and Issuer

This Amendment No. 1 (this "Amendment") amends, as set forth below, the statement on Schedule 13D, dated April 17, 2014 and filed with the SEC on April 28, 2014 (the "Original Schedule 13D"), for Bank of America Corporation and Banc of America Preferred Funding Corporation ("BAPFC") (collectively, the "Reporting Persons") with respect to the variable rate demand preferred shares ("VRDP Shares") of BlackRock MuniYield New Jersey Quality Fund, Inc. (the "Issuer"). This Amendment is being filed as a result of the Issuer being reorganized into BlackRock MuniHoldings New Jersey Quality Fund, Inc. ("MUJ") (the "Reorganization") and the corresponding exchange of the Reporting Person's 644 VRDP Shares of the Issuer for an equal number of variable rate demand preferred shares of MUJ.
