Item 1. Security and Issuer

This Amendment No. 1 (this "Amendment") amends, as set forth below, the statement on Schedule 13D, dated June 3, 2014 and filed with the SEC on June 4, 2014 (the "Original Schedule 13D"), for Bank of America Corporation and Banc of America Preferred Funding Corporation ("BAPFC") (collectively, the "Reporting Persons") with respect to the variable rate munifund term preferred shares ("VMTP Shares") of Nuveen New York Dividend Advantage Municipal Fund 2 (the "Issuer"). This Amendment is being filed as a result of the Issuer being reorganized into Nuveen New York Dividend Advantage Municipal Fund ("NAN") (the "Reorganization") and the corresponding exchange of the Reporting Person's 380 VMTP Shares of the Issuer for an equal number of variable munifund term preferred shares of NAN.

"As a result of the Reorganization, the Reporting Persons no longer own any VMTP Shares of the Issuer."
