Royal Bank of Canada is offering the Geared Buffered Return Notes (the “Notes”) linked to the performance of the S&P 500® Index (the “Reference Asset”). The CUSIP number for the Notes is 78013XDP0. The Notes do not pay interest. If the Final Level of the Reference Asset is greater than the Initial Level, investors will receive a 105.00% leveraged positive return. If the Final Level of the Reference Asset is greater than 75.00% of the Initial Level (the “Buffer Level”), but less than the Initial Level, investors will receive the Principal Amount.

However, if the Final Level is less than the Initial Level by more than the Buffer Percentage, investors will lose 1.3333% of the principal amount of the Notes for each 1% decrease from the Initial Level to the Final Level by more than the Buffer Percentage. Accordingly, investors may lose all or substantially all of their principal amount. Any payments on the Notes are subject to our credit risk.

The Notes will not be listed on any securities exchange.

Investing in the Notes involves a number of risks. The initial estimated value of the Notes as of the date of this pricing supplement is \$943.47 per \$1,000 in principal amount, which is less than the price to public. The actual value of the Notes at any time will reflect many factors, cannot be predicted with accuracy, and may be less than this amount. We describe our determination of the initial

estimated value in more detail below.

RBC Capital Markets, LLC, which we refer to as RBCCM, acting as agent for Royal Bank of Canada, received a commission of \$32.50 per \$1,000 in principal amount of the Notes and used a portion of that commission to allow selling concessions to other dealers of up to \$32.50 per \$1,000 in principal amount of the Notes. The other dealers may forgo, in their sole discretion, some or all of their selling concessions. See “Supplemental Plan of Distribution (Conflicts of Interest)” below.

We may use this pricing supplement in the initial sale of the Notes. In addition, RBCCM or another of our affiliates may use this pricing supplement in a market-making transaction in the Notes after their initial sale. Unless we or our agent informs the purchaser otherwise in the confirmation of sale, this pricing supplement is being used in a market-making transaction.

#### HYPOTHETICAL RETURNS

The examples set out below are included for illustration purposes only. The hypothetical Percentage Changes of the Reference Asset used to illustrate the calculation of the Payment at Maturity (rounded to two decimal places) are not estimates or forecasts of the Final Level or the level of the Reference Asset on any trading day prior to the Maturity Date. All examples are based on the Leverage Factor of 105.00%, the Buffer Percentage of 25.00% (the Buffer Level is 75.00% of the Initial Level), and the Downside Multiplier of 1.3333 (100% divided by 75.00%), and assume that a holder purchased Notes with an aggregate principal amount of \$1,000, and that no market disruption event occurs on the Valuation Date.

Example 1 Calculation of the Payment at Maturity where the Percentage Change is positive.

Percentage Change: 5.00%

Payment at Maturity:  $\$1,000 + [\$1,000 \times (5.00\% \times 105.00\%)] = \$1,000 + \$52.50 = \$1,052.50$

On a \$1,000 investment, a 5% Percentage Change results in a Payment at Maturity of \$1,052.50, a 5.25% return on the Notes.

Example 2 Calculation of the Payment at Maturity where the Percentage Change is negative, but the Final Level is greater than the Buffer Level.

Percentage Change: -15.00%

Payment at Maturity: \$1,000

On a \$1,000 investment, a -15% Percentage Change results in a Payment at Maturity of \$1,000, a 0.00% return on the Notes.

Example 3 Calculation of the Payment at Maturity where the Final Level is less than the Buffer Level.

Percentage Change: -40.00%

Payment at Maturity:  $\$1,000 + [\$1,000 \times (-40.00\% + 25.00\%) \times 1.3333] = \$1,000 - \$200.00 = \$800.00$

On a \$1,000 investment, a -40% Percentage Change results in a Payment at Maturity of \$800.00, a -20.00% return on the Notes.

#### SELECTED RISK CONSIDERATIONS

An invest­ment in the Notes involves sig­nif­i­cant risks. Invest­ing in the Notes is not equiv­al­ent to invest­ing di­rectly in the Refer­ence Asset. These risks are ex­plained in more de­tail in the sec­tion “Ad­di­tion­al Risk Fac­tors Spec­ific to the Notes,” be­gin­ning on page PS-4 of the prod­uct pros­pectus sup­ple­ment. In ad­di­tion to the risks de­scribed in the pros­pectus sup­ple­ment and the prod­uct pros­pectus sup­ple­ment, you should con­sider the fol­low­ing:

**Prin­ci­pal at Risk** – Invest­ors in the Notes could lose all or a sub­stan­tial por­tion of their prin­ci­pal amount if there is a de­cline in the level of the Refer­ence Asset. You will lose 1.3333% of the prin­ci­pal amount of the Notes for each 1% that the Final Level is less than the Initial Level by more than the Buffer Per­cent­age.

**The Notes Do Not Pay Inter­est and Your Return May Be Lower than the Return on a Con­ven­tion­al Debt Security of Com­par­able Ma­tu­rity** – There will be no pe­ri­odic in­ter­est pay­ments on the Notes as there would be on a con­ven­tion­al fixed-rate or float­ing-rate debt security hav­ing the same ma­tu­rity. The re­turn that you will re­ceive on the Notes, which could be neg­a­tive, may be less than the re­turn you could earn on other invest­ments. Even if your re­turn is pos­i­tive, your re­turn may be less than the re­turn you would earn if you bought a con­ven­tion­al senior in­ter­est bear­ing debt security of Royal Bank.

**Pay­ments on the Notes Are Sub­ject to Our Credit Risk, and Changes in Our Credit Rat­ings Are Ex­pected to Affect the Market Value of the Notes** – The Notes are Royal Bank’s senior un­se­cured debt securities. As a re­sult, your re­ceipt of the amount due on the ma­tu­rity date is de­pendent upon Royal Bank’s ab­il­ity to re­pay its ob­ligations at that time. This will be the case even if the level of the Refer­ence Asset in­creases af­ter the Pricing Date. No as­sur­ance can be given as to what our finan­cial con­di­tion will be at the ma­tu­rity of the Notes.

**There May Not Be an Active Trading Market for the Notes—Sales in the Sec­ondary Market May Result in Sig­nif­i­cant Losses** – There may be lit­tle or no sec­ondary market for the Notes. The Notes will not be listed on any securities ex­change. RBCCM and other af­fil­i­ates of Royal Bank may make a market for the Notes; how­ever, they are not re­quired to do so. RBCCM or any other af­fil­i­ate of Royal Bank may stop any market-making ac­tiv­ities at any time. Even if a sec­ondary market for the Notes de­velops, it may not pro­vide sig­nif­i­cant liq­uid­ity or trade at prices ad­van­ta­geous to you. We ex­pect that transac­tion costs in any sec­ondary market would be high. As a re­sult, the dif­fer­ence be­tween bid and asked prices for your Notes in any sec­ondary market could be sub­stan­tial.

**You Will Not Have Any Rights to the Securities In­cluded in the Refer­ence Asset** – As a holder of the Notes, you will not have vot­ing rights or rights to re­ceive cash di­vid­ends or other dis­tri­butions or other rights that holders of securities in­cluded in the Refer­ence Asset would have. The Final Level will not re­flect any di­vid­ends paid on the securities in­cluded in the Refer­ence Asset, and ac­cord­ingly, any pos­i­tive re­turn on the Notes may be less than the po­ten­tial pos­i­tive re­turn on those securities.

**The Initial Es­ti­mated Value of the Notes Is Less than the Price to the Public** – The initial es­ti­mated value set forth on the cover page of this pricing sup­ple­ment does not re­present a minimum price at which we, RBCCM or any of our af­fil­i­ates would be will­ing to pur­chase the Notes in any sec­ondary market (if any ex­ists) at any time. If you at­tempt to sell the Notes prior to ma­tu­rity, their market value may be lower than the price you paid for them and the initial es­ti­mated value. This is due to, among other things, changes in the level of the Refer­ence Asset, the bor­row­ing rate we pay to issue securities of this kind, and the in­clu­sion in the price to the public of the under­writ­ing dis­count and the es­ti­mated costs re­lat­ing to our hedging of the Notes. These fac­tors, to­gether with vari­ous credit, market and economic fac­tors over the term of the Notes, are ex­pected to re­duce the price at which you may be able to sell the Notes in any sec­ondary market and will affect the value of the Notes in com­plex and un­pre­dictable ways. As­sum­ing no change in market con­di­tions or any other re­levant fac­tors, the price, if any, at which you may be able to sell your Notes prior to ma­tu­rity may be less than your orig­inal pur­chase price, as any such sale price would not be ex­pected to in­clude the

underwriting discount and the hedging costs relating to the Notes. In addition to bid-ask spreads, the value of the Notes determined for any secondary market price is expected to be based on the secondary rate rather than the internal funding rate used to price the Notes and determine the initial estimated value. As a result, the secondary price will be less than if the internal funding rate

was used. The Notes are not designed to be short-term trading instruments. Accordingly, you should be able and willing to hold your Notes to maturity.

The Initial Estimated Value of the Notes on the Cover Page of this Pricing Supplement Is an Estimate Only, Calculated as of the Time the Terms of the Notes Were Set –The initial estimated value of the Notes is based on the value of our obligation to make the payments on the Notes, together with the mid-market value of the derivative embedded in the terms of the Notes. See “Structuring the Notes” below. Our estimate is based on a variety of assumptions, including our credit spreads, expectations as to dividends, interest rates and volatility, and the expected term of the Notes. These assumptions are based on certain forecasts about future events, which may prove to be incorrect. Other entities may value the Notes or similar securities at a price that is significantly different than we do. The value of the Notes at any time after the Pricing Date will vary based on many factors, including changes in market conditions, and cannot be predicted with accuracy. As a result, the actual value you would receive if you sold the Notes in any secondary market, if any, should be expected to differ materially from the initial estimated value of your Notes.

Market Disruption Events and Adjustments – The payment at maturity and the Valuation Date are subject to adjustment as described in the product prospectus supplement. For a description of what constitutes a market disruption event as well as the consequences of that market disruption event, see “General Terms of the Notes—Market Disruption Events” in the product prospectus supplement.

#### INFORMATION REGARDING THE REFERENCE ASSET

All disclosures contained in this pricing supplement regarding the Reference Asset, including, without limitation, its make up, method of calculation, and changes in its components, have been derived from publicly available sources. The information reflects the policies of, and is subject to change by, S&P Dow Jones Indices LLC (“S&P”). S&P, which owns the copyright and all other rights to the Reference Asset, has no obligation to continue to publish, and may discontinue publication of, the Reference Asset. The consequences of S&P discontinuing publication of the Reference Asset are discussed in the section of the product prospectus supplement entitled “General Terms of the Notes—Unavailability of the Level of the Reference Asset on a Valuation Date.” Neither we nor RBCCM accepts any responsibility for the calculation, maintenance or publication of the Reference Asset or any successor index. The Reference Asset is intended to provide an indication of the pattern of common stock price movement. The calculation of the level of the Reference Asset is based on the relative value of the aggregate market value of the common stocks of 500 companies as of a particular time compared to the aggregate average market value of the common stocks of 500 similar companies during the base period of the years 1941 through 1943. S&P calculates the Reference Asset by reference to the prices of the constituent stocks of the Reference Asset without taking account of the value of dividends paid on those stocks. As a result, the return on the Notes will not reflect the return you would realize if you actually owned the Reference Asset constituent stocks and received the dividends paid on those stocks.

Effective with the September 2015 rebalance, consolidated share class lines will no longer be included in the Reference Asset. Each share class line will be subject to public float and liquidity criteria individually, but the company’s total market capitalization will be used to evaluate each share class line. This may result in one listed share class line of a company being included in the Reference Asset while a second listed share class line of the same company is excluded.

#### Computation of the Reference Asset

While S&P currently employs the following methodology to calculate the Reference Asset, no assurance can be given that S&P will not modify or change this methodology in a manner that may affect the Payment at Maturity. Historically, the market value of any component stock of the Reference Asset was calculated as the product of the market price per share and the number of then outstanding shares of such component stock. In March 2005, S&P began shifting the Reference Asset halfway from a market capitalization weighted formula to a float-adjusted formula, before moving the Reference Asset to full float adjustment on September 16, 2005. S&P’s criteria for selecting stocks for the Reference Asset did not change with the shift to float adjustment. However, the adjustment affects each company’s weight in the Reference Asset.

Under float adjustment, the share counts used in calculating the Reference Asset reflect only those shares that are available to investors, not all of a company’s outstanding shares. Float adjustment excludes shares that are closely held by control groups, other publicly traded companies or government agencies.

In September 2012, all shareholdings representing more than 5% of a stock’s outstanding shares, other than holdings by “block owners,” were removed from the float for purposes of calculating the Reference Asset. Generally, these “control holders” will include officers and directors, private equity, venture capital and special equity firms, other publicly traded companies that hold shares for control, strategic partners, holders of restricted shares, ESOPs, employee and family trusts, foundations associated with the company, holders of unlisted share classes of stock, government entities at all levels (other than government retirement/pension funds) and any individual person who controls a 5% or greater stake in a company as reported in regulatory filings. However, holdings by block owners, such as depositary banks, pension funds, mutual funds and ETF providers, 401(k) plans of the company, government retirement/pension funds, investment funds of insurance companies, asset managers and investment funds,

independent foundations and savings and investment plans, will ordinarily be considered part of the float. Treasury stock, stock options, equity participation units, warrants, preferred stock, convertible stock, and rights are not part of the float. Shares held in a trust to allow investors in countries outside the country of domicile, such as depository shares and Canadian exchangeable shares are normally part of the float unless those shares form a control block.

For each stock, an investable weight factor (“IWF”) is calculated by dividing the available float shares by the total shares outstanding. Available float shares are defined as the total shares outstanding less shares held by control holders. This calculation is subject to a 5% minimum threshold for control blocks. For example, if a company’s officers and directors hold 3% of the company’s shares, and no other control group holds 5% of the company’s shares, S&P would assign that company an IWF of 1.00, as no control group meets the 5% threshold. However, if a company’s officers and directors hold 3% of the company’s shares and another control group holds 20% of the company’s shares, S&P would assign an IWF of 0.77, reflecting the fact that 23% of the company’s outstanding shares are considered to be held for control. As of July 31, 2017, companies with multiple share class lines are no longer eligible for inclusion in the Reference Asset. Constituents of the Reference Asset prior to July 31, 2017 with multiple share class lines will be grandfathered in and continue to be included in the Reference Asset. If a constituent company of the Reference Asset reorganizes into a multiple share class line structure, that company will remain in the Reference Asset at the discretion of the S&P Index Committee in order to minimize turnover.

The Reference Asset is calculated using a base-weighted aggregate methodology. The level of the Reference Asset reflects the total market value of all 500 component stocks relative to the base period of the years 1941 through 1943. An indexed number is used to represent the results of this calculation in order to make the level easier to use and track over time. The actual total market value of the component stocks during the base period of the years 1941 through 1943 has been set to an indexed level of 10. This is often indicated by the notation 1941-43 = 10. In practice, the daily calculation of the Reference Asset is computed by dividing the total market value of the component stocks by the “index divisor.” By itself, the index divisor is an arbitrary number. However, in the context of the calculation of the Reference Asset, it serves as a link to the original base period level of the Reference Asset. The index divisor keeps the Reference Asset comparable over time and is the manipulation point for all adjustments to the Reference Asset, which is index maintenance.

#### Index Maintenance

Index maintenance includes monitoring and completing the adjustments for company additions and deletions, share changes, stock splits, stock dividends, and stock price adjustments due to company restructuring or spinoffs. Some corporate actions, such as stock splits and stock dividends, require changes in the common shares outstanding and the stock prices of the companies in the Reference Asset, and do not require index divisor adjustments.

To prevent the level of the Reference Asset from changing due to corporate actions, corporate actions which affect the total market value of the Reference Asset require an index divisor adjustment. By adjusting the index divisor for the change in market value, the level of the Reference Asset remains constant and does not reflect the corporate actions of individual companies in the Reference Asset. #### SUPPLEMENTAL DISCUSSION OF U.S. FEDERAL INCOME TAX CONSEQUENCES

The following disclosure supplements, and to the extent inconsistent supersedes, the discussion in the product prospectus supplement dated January 12, 2016 under “Supplemental Discussion of U.S. Federal Income Tax Consequences.”

Under Section 871(m) of the Code, a “dividend equivalent” payment is treated as a dividend from sources within the United States. Such payments generally would be subject to a 30% U.S. withholding tax if paid to a non-U.S. holder. Under U.S. Treasury Department regulations, payments (including deemed payments) with respect to equity-linked instruments (“ELIs”) that are “specified ELIs” may be treated as dividend equivalents if such specified ELIs reference an interest in an “underlying security,” which is generally any interest in an entity taxable as a corporation for U.S. federal income tax purposes if a payment with respect to such interest could give rise to a U.S. source dividend. However, the IRS has issued guidance that states that the U.S. Treasury Department and the IRS intend to amend the effective dates of the U.S. Treasury Department regulations to provide that withholding on dividend equivalent payments will not apply to specified ELIs that are not delta-one instruments and that are issued before January 1, 2019. Based on our determination that the Notes are not delta-one instruments, non-U.S. holders should not be subject to withholding on dividend equivalent payments, if any, under the Notes. However, it is possible that the Notes could be treated as deemed reissued for U.S. federal income tax purposes upon the occurrence of certain events affecting the Reference Asset or the Notes (for example, upon a Reference Asset rebalancing), and following such occurrence the Notes could be treated as subject to withholding on dividend equivalent payments. Non-U.S. holders that enter, or have entered, into other transactions in respect of the Reference Asset or the Notes should consult their tax advisors as to the application of the dividend equivalent withholding tax in the context of the Notes and their other transactions. If any payments are treated as dividend equivalents subject to withholding, we (or the applicable withholding agent) would be entitled to withhold taxes without being required to pay any additional amounts with respect to amounts so withheld.

Delivery of the Notes will be made against payment for the Notes on January 31, 2018, which is the third (3rd) business day following the Pricing Date (this settlement cycle being referred to as “T+3”). Accordingly, purchasers who wish to trade the Notes more than two business days prior to the original issue date will be required to specify alternative settlement arrangements to prevent a failed settlement.

The value of the Notes shown on your account statement may be based on RBCCM’s estimate of the value of the Notes if RBCCM or another of our affiliates were to make a market in the Notes (which it is not obligated to do). #### STRUCTURING THE NOTES

The Notes are our debt securities, the return on which is linked to the performance of the Reference Asset. As is the case for all of our debt securities, including our structured notes, the economic terms of the Notes reflect our actual or perceived creditworthiness at the time of pricing. In addition, because structured notes result in increased operational, funding and liability management costs to us, we typically borrow the funds under these Notes at a rate that is more favorable to us than the rate that we might pay for a conventional fixed or floating rate debt security of comparable maturity. Using this relatively lower implied borrowing rate rather than the secondary market rate, is a factor that reduced the initial estimated value of the Notes at the time their terms were set. Unlike the estimated value included in this pricing supplement, any value of the Notes determined for purposes of a secondary market transaction may be based on a different funding rate, which may result in a lower value for the Notes than if our initial internal funding rate were used.

In order to satisfy our payment obligations under the Notes, we may choose to enter into certain hedging arrangements (which may include call options, put options or other derivatives) on the issue date with RBCCM or one of our other subsidiaries. The terms of these hedging arrangements take into account a number of factors, including our creditworthiness, interest rate movements, the volatility of the Reference Asset, and the tenor of the Notes. The economic terms of the Notes and their initial estimated value depend in part on the terms of these hedging arrangements.

The lower implied borrowing rate is a factor that reduced the economic terms of the Notes to you.
